## Interest rates

The Banque centrale du Luxembourg (BCL) informs that, based on preliminary data, the main interest rates applied by Luxembourg's credit institutions to euro area households and non-financial corporations (NFCs) for their loan and deposit operations have on average evolved as follows in June 2025.

## Representative interest rates on new contracts<sup>1</sup> – loans and deposits – concluded with households

The variable<sup>2</sup> interest rate on mortgage loans granted to households has decreased by 4 basis points on a monthly basis to reach 3.28% in June 2025 compared to 3.32% in May 2025 and the volume of these newly granted loans has increased by 153 million euros to reach 405 million euros in June compared to 252 million euros in May. On a yearly basis, the interest rate has decreased by 154 basis points whereas the volume of newly granted loans has increased by 237 million euros.

The fixed³ interest rate on mortgage loans granted to households with an initial fixation rate of over one year and up to five years remained unchanged on a monthly basis at 3.20% in June 2025 while the volume reaches 55 million euros. The fixed interest rate with an initial fixation rate of over five years and up to ten years increased by 7 basis points compared to May 2025 to reach 3.55%. The corresponding monthly volumes increased by 14 million euros to reach 66 million euros.

<sup>3</sup> Fixed interest rate weighted by the amounts of contracts for all mortgage loans granted, whatever the initial rate fixation period (above 1 year). This series has been published by the BCL since February 2009 only for methodological reasons linked to the identification of reporting agents.



<sup>1</sup> New contracts refer to any new agreement concluded between the household or the non-financial corporation and the reporting agent. New contracts include all financial contracts which mention for the first time the interest rate pertaining to the deposit or credit and all renegotiations of existing deposits or credits.

Concerning real estate loans with an initial rate fixation period over 10 years, the monthly volumes increased by 110 million euros since May to reach 405 million euros. Interest rates of these loans are grouped by intervals of five years of initial rate fixation<sup>4</sup>, and have changed as follows compared with May:

- The interest rates with an interest rate fixation of over 10 years and up to 15 years decreased by 19 basis points to reach 3.48%.
- The interest rates with an interest rate fixation of over 15 years and up to 20 years decreased by 5 basis points to reach 3.16%.
- The interest rates with an interest rate fixation of over 20 years and up to 25 years increased by 1 basis point to reach 3.37%.
- The interest rates with an interest rate fixation of over 25 years and up to 30 years decreased by 1 basis point to reach 3.53%.
- The interest rates with an interest rate fixation of over 30 years decreased by 6 basis points to reach 3.60%.

It is important to mention that the indicated rates of the different interest rate fixations are average rates, where the calculations are based on a sample of banks and which are taking into account the volumes of granted loans.

The interest rate on consumer loans that have an initial fixation period above 1 year and below or equal to 5 years has decreased by 1 basis point since May to reach 4.80% in June 2025. The volume of newly granted loans has decreased by 2 million euros to reach 25 million euros in June compared to 27 million euros in May. On a yearly basis, the interest rate has decreased by 4 basis points whereas the volume of new lending has decreased by 2 million euros.

The interest rate on households' fixed-term deposits that have an initial maturity below or equal to 1 year has reached 146 basis points in June 2025 from 171 basis points in May 2025. On a yearly basis, this rate has decreased by 178 basis points.






<sup>&</sup>lt;sup>4</sup> Following an update of the statistical data collection, since December 2022 the BCL has been collecting a breakdown of interest rates with an initial fixation rate of over 10 years in five-year intervals.


The following graphs provide a detailed overview of the evolution of interest rates and the volumes of the new business loans. Furthermore, the evolution of the interest rates over the past two years is presented in more detail.












The variable interest rate on loans below or equal to 1 million euros granted to NFCs decreased by 11 basis points in June 2025 to 3.45%, compared to 3.56% in May, and the volume has increased by 5 million euros to reach 122 million euros in June from 117 million euros in May. On a yearly basis, this interest rate has decreased by 103 basis points and the volume of newly granted loans has decreased by 7 million euros.

The variable interest rate on loans above 1 million euros granted to NFCs has increased by 68 basis points on a monthly basis to 2.60% during the last reference period, compared to 1.92% in May. The volume of newly granted loans has increased by 1 328 million euros to reach 2 911 million euros in June compared to 1 583 million euros in May. On a yearly basis, this interest rate has decreased by 120 basis points and the volume of newly granted loans has increased by 990 million euros.

<u>The interest rate on fixed-term deposits</u> of NFCs with an initial maturity below or equal to 1 year has decreased by 17 basis points on a monthly basis since May to reach 1.79% in June 2025. On a yearly basis, this interest rate has decreased by 170 basis points.

## Weighting method

The interest rates applied to new contracts are weighted within the categories of instruments concerned by the amounts of individual contracts. This results from the compilation of national aggregates carried out by reporting credit institutions and by the BCL.
