BGL BNP Paribas opens seKoia: a new sustainable head office built for the future

After two and a half years of work, BGL BNP Paribas officially opened its new head office, seKoia, in the centre of Kirchberg on 18 September. More than just a building, it is a collaborative project designed to support developments in the banking world, address environmental concerns and provide a workspace that is adapted to employees' needs.

The opening ceremony took place in the presence of HRH Grand Duke Henri of Luxembourg, Gilles Roth, Finance Minister, Lydie Polfer, Mayor of the City of Luxembourg, Thierry Laborde, Chief Operating Officer of BNP Paribas, Béatrice Belorgey, Chair of the BGL BNP Paribas Executive Committee and Head of the BNP Paribas Group entities in Luxembourg, and Bob Kieffer, Chair of the BGL BNP Paribas Board of Directors.

A head office designed to suit new working methods

With 1,100 workstations spread over 18,500m² on eight floors, seKoia's architecture is ideal for the flexible, agile and hybrid work that we have come to know in recent years. Teamworking, brainstorming and quiet areas, configurable spaces, and conference rooms fitted with the latest technologies all create a seamless environment that can be adapted to employees' needs and that serves clients' expectations in the best possible way.

With this project, the bank has created an inspirational workspace which is essential for nurturing creativity, innovation and wellbeing on a daily basis, and which allows to welcome and accompany clients and partners in a modern and pleasant environment.

Employee wellbeing and environmental standards

Following up on the bank's commitment to becoming more energy efficient, which led to the award of ISO 50001 certification in January 2022 (renewed in March 2025), seKoia stands out for a sustainable design that allies energy efficiency with employee wellbeing.

Requiring 70% less energy than the old head office, seKoia will meet the highest environmental standards as the bank targets not only BREEAM®, HQE International® and DGNB® certification for its new offices, but also the BBCA® (low carbon building) label, ensuring minimum energy consumption during the building's construction and use. Employee wellbeing has not been forgotten either, as the bank is also aiming to obtain OsmoZ® certification.



A name chosen by and for our staff

The name seKoia was chosen by staff through an in-house competition and embodies the local roots, strength and longevity of a bank that has been in Luxembourg for over a century. The K in seKoia refers to the Kirchberg district in which BGL BNP Paribas has been located for the past 30 years.

Like the sequoia, or millennium tree, the building symbolises an institution that grows continuously over a long period of time.

"seKoia is not only our new head office; it is also the hallmark of an innovative and responsible bank that is deeply entwined in Luxembourg and listens to the needs of its clients and staff. - 1st quarter of 2023: installation of the worksite and start of infrastructure works
- 4th quarter of 2023: start of superstructure works
- 7 December 2023: the first brick is laid
- 9 June 2025: the first staff move in
- 29 September 2025: the last staff move in
